Charity Program: FREE DISTRIBUTION OF ESSENTIAL RATION TO POOR PEOPLE.

Charity Implementation area: VILLAGES IN & AROUND SALUGARA.

Implementation date: MAY 2020.

No. of Beneficiaries: 300 FAMILIES.

Total cost of the charity program: 149,220/- (One lakh forty nine thousand two hundred twenty only).

Since the Covid-19 pandemic is spreading out of control and spreading across the globe at an alarming rate, the Government of India as a preventive measure to contain the spread of this virus has imposed nationwide lockdown for the last almost three months. The situation still is grim and the government may continue the lockdown if the situation didn't improve.

This pandemic and the lockdown has caused the nation's economic slowdown and the worst affected victims are the poor people, daily wages and labourers who became jobless as the factories & workplaces were shut. Millions of people loss their job and sources of income, there were shortages of food and the reports .

Considering this grim situation the board member has in consultation with the local Panchayat decided to distribute free essential ration to 300 poor and needy people who are worst affected by Covid-19 pandemic. Local Panchayat and their members sorted out the list of poor & most needy people from their locality. Following is the list of ration for distribution for one family:

- 2 kg Potato
- 1 pkt salt
- 5 kg Rice
- 1 kg Chati
- 5 kg Atta

Following is the number of beneficiaries and area of execution of this charity program:

38 poor families from	Toribari village	distributed on 24 th May 2020.
55 poor families from	Betgara & SinghiJhora	distributed on 24 th May 2020.
50 poor families from	Salugara area	distributed on 26 th May 2020.
19 poor families from	Demdema village	distributed on 26 th May 2020.
51 poor families from	Shiv Nagar village	distributed on 26 th May 2020.
62 poor families from	Rajfapri village	distributed on 26 th May 2020.
25 poor families from	random locations	distributed on 26 th May 2020.

A total number of 300 families were directly benefited from this charity program carried out by our trust and the total expenditure of this program is Rs. 149,220/- (Total Rupees one lakh forty nine thousand two hundred twenty only).

The village Panchayat and the beneficiaries themselves expressed their gratitude in receiving such support at this time of distress.
